AN ORDINANCE TO CORRECT THE ROAD AND DRAINAGE INVENTORY TO INCLUDE ADAMS AVENUE; COMANCHE DRIVE LATERAL; SANDLEWOOD COURT LATERAL; AND AN EXTENSION OF FALCONER BLVD., IN SAID INVENTORY. (WARDS 3 & 5, DISTRICTS 3, 5 & 6).

WHEREAS, the St. Tammany Parish Selective Road and Drainage Inventories require updating/amending periodically to provide for corrections/additions/deletions to the road and drainage inventories based upon the recommendation of the Department of Engineering, Director of Public Works, 911 Facilitator, or Certificate of Road and/or Drainage Maintenance by Area Foreman; Act of Exchange and/or Act of Donation.

THE PARISH OF ST. TAMMANY HEREBY ORDAINS, in regular session convened that:

SECTION I: The St. Tammany Parish Selective Road and Drainage Maintenance System Inventory is amended as follows:

1. Add Adams Avenue, located east and west from end of 4th Street, per Resolution Planning Commission Series # 09-066, (Ward 3, District 5); and
2. Add Comanche Drive Lateral, a/k/a Arrowwood Weir, located north of Comanche Drive, (Ward 3, District 3); and
3. Add Sandlewood Court Lateral, a/k/a Parc Du Lac Weir, located southwest from Piper Lane for approximately 270 feet, (Ward 5, District 6); and
4. Add an extension to Falconer Blvd (R03L161), approximately 3,610 feet, located north from Crestwood Blvd., (Ward 3, District 5).

SECTION II: The Department of Public Works is directed to obtain, place, and/or remove the appropriate streets signs as necessary to effectuate said amendments.

REPEAL: All ordinances or parts of Ordinances in conflict herewith are hereby repealed.

SEVERABILITY: If any provision of this Ordinance shall be held to be invalid, such invalidity shall not affect other provisions herein which can be given effect without the invalid provision and to this end the provisions of this Ordinance are hereby declared to be severable.

EFFECTIVE DATE: This Ordinance shall become effective fifteen (15) days after adoption.
