ORDINANCE AUTHORIZING THE PARISH OF ST. TAMMANY, THROUGH THE OFFICE OF THE PARISH PRESIDENT, TO ACQUIRE TEMPORARY CONSTRUCTION SERVITUDES FOR THE ST. TAMMANY ADVANCED CAMPUS DEVELOPMENT (WARD 7, DISTRICT 11).

WHEREAS, there is a need and a public purpose for the acquisition of certain temporary construction servitudes of immovable property for the St. Tammany Advanced Campus development; and

WHEREAS, the necessary temporary construction servitude is depicted on the plan attached hereto as Exhibit "A".

THE PARISH OF ST. TAMMANY HEREBY ORDAINS: to authorize the Parish of St. Tammany to acquire, whether by donation or for no greater than fair market value as determined by appraisal, all that certain temporary construction servitude depicted on Exhibit "A".

BE IT FURTHER ORDAINED: that pursuant to all applicable provisions of law, the Office of the Parish President is directed and authorized to do whatever is necessary to acquire the temporary construction servitudes.

BE IT FURTHER ORDAINED: that any and all actions taken by the Office of the Parish President in furtherance of the actions contemplated herein are ratified and accepted accordingly.

REPEAL: All ordinances or parts of Ordinances in conflict herewith are hereby repealed.

SEVERABILITY: If any provision of this Ordinance shall be held to be invalid, such invalidity shall not affect other provisions herein which can be given effect without the invalid provision and to this end the provisions of this Ordinance are hereby declared to be severable.

EFFECTIVE DATE: This Ordinance shall become effective fifteen (15) days after adoption.

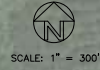
