ORDINANCE ESTABLISHING A NO PARKING AND ONE WAY TRAFFIC ZONE ON PORTIONS OF STONE STREET (8-L-17), REBEL DRIVE (8-L-18), AND CORAL STREET (8-L-19). (WARD 8, DISTRICT 8 & 9).

WHEREAS, St. Tammany Parish Government is charged with protecting the safety and welfare of citizens of the Parish.

THE PARISH OF ST. TAMMANY HEREBY ORDAINS: that

SECTION I; A "No Parking" between the school hours of 7 a.m. - 9 a.m. and 2 p.m - 4 p.m. and a "One Way" traffic zone is hereby established on a portion of Stone Street (8-L-17) in a westerly direction from N. Pearl Drive to Rebel Drive; on a portion of Rebel Drive (8-L-18) in a southernly direction from Stone Street to Coral Avenue and on Coral Avenue (18-L-19) in a easterly direction from rebel Drive to N. Pearl Drive on Monday through Friday between the hours of 6:00 a.m. and 6:00 p.m.

SECTION II: The Parish Department of Public Works is Directed to post the appropriate signs at these locations.

REPEAL: All ordinances or parts of Ordinances in conflict herewith are hereby repealed.

SEVERABILITY: If any provision of this Ordinance shall be held to be invalid, such invalidity shall not affect other provisions herein which can be given effect without the invalid provision and to this end the provisions of this Ordinance are hereby declared to be severable.

EFFECTIVE DATE: This Ordinance shall become effective fifteen (15) days after adoption.
