## **Ordinance Administrative Comment**

ORDINANCE TO AUTHORIZE THE PARISH OF ST. TAMMANY, THROUGH THE OFFICE OF THE PARISH PRESIDENT, TO EXTEND A LEASE ON OFFICE SPACE IN THE KOOP DRIVE ADMINISTRATIVE COMPLEX TO THE HONORABLE SENATOR JOHN KENNEDY.
