**Administrative Comment**  
**Amendment No. 12 - 2017 Operating Budget - November 2017**

**This budget amendment is to:**

- a **130 - HWY. 21 ECONOMIC DEVELOPMENT SALES TAX DISTRICT FUND**  

To amend the budget to increase expenditures by \$269,000 for Hwy. 21 Interchange Enhancements and \$239,000 for Airport Rd. Interchange Enhancements. These Gateway Projects include the funding for clearing, pruning, planting, and maintenance of the landscaping during the 18 month establishment period.
- b **133 - HWY. 59 ECONOMIC DEVELOPMENT SALES TAX DISTRICT FUND**  

To amend the budget to increase expenditures by \$25,000 for a traffic study at Alamosa Business Park.

To amend the budget to increase expenditures by \$58,275 for the 25% local match for a generator at the Northshore Technical Community College STEM Center.
- c **134 - HWY. 1077 ECONOMIC DEVELOPMENT SALES TAX DISTRICT FUND**  

To amend the budget to increase expenditures by \$197,336.50 for the cost of surveying, permitting, and land services related to the design of a new connector road from Seymour Myers Blvd. to Perrilloux Rd.
- d **622 - UTILITY OPERATIONS FUND**  

To amend the budget to increase expenditures by \$750,000 for design of a new sewer force main and headworks from the Fauborg Couquille sewer lift station to the Guste Island waste water treatment plant.
