AN ORDINANCE TO AMEND CHAPTER 15 OF THE ST. TAMMANY PARISH CODE OF ORDINANCES ENTITLED OFFENSES MISCELLANEOUS ARTICLE I TO CREATE SECTION 15-006.00 PROHIBITING COMMERCIAL ACTIVITY AT ALL PARISH OWNED BOAT LAUNCHES AND ADJOINING PARKING LOTS

WHEREAS, public boat launches owned and/or operated by St. Tammany Parish Government are meant for the use of enjoyment of the public for recreational activities; and

WHEREAS, the use of said public boat launches and adjoining parking lots for commercial activity threatens the use and enjoyment of citizens of and visitors to St. Tammany Parish for recreational purposes; and

WHEREAS, in order to preserve the recreational aspect of all public boat launches owned and/or operated by St. Tammany Parish Government, the Parish Council desires to prohibit commercial activity at said boat launches; and

WHEREAS, any person(s) found to be in violation of this provision shall be subject to the penalty provisions of Section 1-008.00 of this Code.

THE PARISH OF ST. TAMMANY HEREBY ORDAINS: that no person, firm, company, or corporation shall engage in any commercial activity at any public boat launch, including adjoining parking areas owned and/or operated by St. Tammany Parish Government.

The Parish of St. Tammany further ordains that Chapter 15 of the St. Tammany Code of Ordinances entitled Offenses - Miscellaneous be amended to create section 15-006.00 prohibiting commercial activity at all public boat launches and adjoining parking area owned and/or operated by St. Tammany Parish Government.

The Parish of St. Tammany further ordains that any person(s) found to be in violation of this provision shall be subject to the penalty provisions of Section 1-008.00 of this Code.

REPEAL: All ordinances or parts of Ordinances in conflict herewith are hereby repealed.

SEVERABILITY: If any provision of this Ordinance shall be held to be invalid, such invalidity shall not affect other provisions herein which can be given effect without the invalid provision and to this end the provisions of this Ordinance are hereby declared to be severable.

EFFECTIVE DATE: This Ordinance shall become effective fifteen (15) days after adoption.
