2018 GRANTS BUDGET - DECEMBER 2018

<u>Fund No</u>	<u>Title</u>	<u>Granting Agency & Description</u>
415-01	Bootlegger Rd. Sidewalk	State of LA, DOTD: Grant award received for engineering and construction of a sidewalk from Coquille to White Chapel Rd. Total cost is \$875,000 and the local match of \$350,000 is to be funded by Capital Projects Fund 300 - Sales Tax District 3 - Parishwide.
418-07	Local Coastal Zone (18-19)	State of LA, Department of Natural Resources: Grant award received for local coastal zone program implementation. Grant has a 100% match, which is to be funded in-kind by salaries and benefits recorded in the General Fund and Public Works Fund.
425-02	CSBG FY18	State of LA, LA Workforce Commission: Grant award received for supportive services for low income families.
450-20	FTA-2016/17 5307 Urban Transit Operations	State of LA, DOTD: Grant award received for transit operations in the amount of \$4,634,221. Grant has a 50% match which is to be funded by COAST millage for elderly transit, STARC, cash fares, and a transfer in from 450-25 Mass Transit Program FY 18 Part B Funds for any excess of expenditures over the remaining funding sources. Grant includes unallocated funding for future capital needs which will be added at a later date.
450-25	Mass Transit Program FY 18 Part B Funds	State of LA, DOTD: Annual allocation received from the Transportation Trust Fund in accordance with R. S. 48:756 (B-E) for the mass transit program.
460-12	CDBG-Entitlement FY 2018	HUD: Grant award received for professional and contractual public service programs such as house and sewer repair, house rehabilitation, housing assistance, transit vouchers, and administrative costs. Grant includes unallocated funding for future capital needs which will be added at a later date.
