RESOLUTION TO ACKNOWLEDGE THE AUTHORITY PURSUANT TO HOME RULE CHARTER SECTIONS 1-04, 1-06, 3-01 AND 3-09 FOR ST. TAMMANY PARISH GOVERNMENT, THROUGH THE OFFICE OF THE PARISH PRESIDENT, TO EXECUTE AN INTERGOVERNMENTAL AGREEMENT WITH THE STATE OF LOUISIANA, DEPARTMENT OF TRANSPORTATION AND DEVELOPMENT, FOR THE FUNDING AND CONSTRUCTION OF AN ACCESS ROAD (WARD 8, DISTRICT 13).

WHEREAS, the State of Louisiana, Department of Transportation and Development ("DOTD") seeks to have constructed an access road in the proximity of State Route LA 433 and U.S. Highway No. 90, and/or other improvements as related to the same (the "Project"); and

WHEREAS, the Project would serve to connect State Route LA 433 to Lots 7, 8 and Parcel "D" of Rigolets Estates Subdivision, and/or as otherwise shown on final plans of construction obtained by DOTD, and would improve traffic flows and/or provide an additional means of transportation for St. Tammany Parish citizens and residents in Rigolets Estates Subdivision, St. Tammany Parish, Louisiana (the "Project"); and

WHEREAS, DOTD desires to obtain ownership of and transfer to St. Tammany Parish Government ("Parish") certain necessary parcel(s) and/or right(s)-of-way for the foregoing Project and improvements, and further desires to contribute to Parish all necessary funding for the Project; and

WHEREAS, in consideration of the shared benefit to Parish and DOTD as concerning the foregoing Project, Parish desires to undertake certain construction and/or related obligations for the Project, and to cooperate with DOTD through the execution of an Intergovernmental Agreement.

THE PARISH OF ST. TAMMANY HEREBY RESOLVES that St. Tammany Parish Government, through the Office of the Parish President, pursuant to Home Rule Charter sections 1-04, 1-06, 3-01 and 3-09 is authorized to enter into an Intergovernmental Agreement, which meets or exceeds all requirements of Louisiana Law and jurisprudence, with the State of Louisiana, Department of Transportation and Development and/or other necessary parties for the funding and construction of an access road in the Rigolets Estates Subdivision, and/or related improvements, and to take any and all actions necessary in furtherance of same.
