AN ORDINANCE TO ESTABLISH A NO PARKING ZONE ON 5TH STREET (R04A055) WARD 4, DISTRICT 4

WHEREAS, the Department of Public Works finds it necessary to impose a no parking zone to prohibit the parking of vehicles within the rights of way of 5th Street (R04A055), to protect the health, safety and wellbeing of motorists traversing said roadway.

THE PARISH OF ST. TAMMANY HEREBY ORDAINS: that the Department of Public Works is authorized and directed to place signs effectuating a No Parking zone within the rights of way of 5th Street (R04A055), to protect the health, safety and wellbeing of motorists traversing said roadway.

REPEAL: All ordinances or parts of Ordinances in conflict herewith are hereby repealed.

SEVERABILITY: If any provision of this Ordinance shall be held to be invalid, such invalidity shall not affect other provisions herein which can be given effect without the invalid provision and to this end the provisions of this Ordinance are hereby declared to be severable.

EFFECTIVE DATE: This Ordinance shall become effective fifteen (15) days after adoption.


