TAMMANY, THROUGH THE OFFICE OF THE PARISH PRESIDENT, TO EXECUTE A COOPERATIVE ENDEAVOR AGREEMENT WITH THE REGIONAL PLANNING COMMISSION FOR A TRAFFIC CIRCULATION AND CORRIDOR ANALYSIS ALONG US 190 BUSINESS FROM BETH DRIVE TO HOOVER DRIVE (WARD 8, DISTRICTS 12, 13 AND 14)

WHEREAS, Parish desires to provide funding for the local match in order to facilitate the Regional Planning Commission's procurement of the study.

THE PARISH OF ST. TAMMANY HEREBY RESOLVES that St. Tammany Parish Government, through the Office of the Parish President, pursuant to Home Rule Charter sections 1-04, 1-06, 3-01 and 3-09, is authorized to execute a Cooperative Endeavor Agreement with the Regional Planning Commission, which meets or exceeds all requirements of Louisiana law and jurisprudence, regarding the traffic circulation and corridor analysis for US 190 Business from Beth Drive to Hoover Drive in Slidell and to take all actions necessary, including entering into all agreements or negotiations in furtherance of the actions contemplated herein.

Parish seeks to enter into a Cooperative Endeavor Agreement with the Regional Planning Commission for a land use and transportation study for the Fremaux area. The general boundaries are U.S. 190 Business ("Shortcut Road") between Beth and Hoover Drives. RPC will procure and administer a contract with a vendor. Parish will provide the local match for DOTD funds otherwise provided to RPC.

Based on an estimated project cost of \$140,000.00, Parish's local match is 20% or approximately \$28,000.00.
