ORDINANCE AUTHORIZING THE PARISH OF ST. TAMMANY, THROUGH THE OFFICE OF THE PARISH PRESIDENT, TO ACQUIRE A TEMPORARY CONSTRUCTION SERVITUDE FOR THE MCDONALD STREET DRAINAGE PROJECT (WARD 4, DISTRICT 7)

WHEREAS, there is a need and a public purpose for the acquisition of a temporary construction servitude on immovable property for the McDonald Street Drainage project; and

WHEREAS, the necessary temporary construction servitude is depicted on the plan attached hereto.

THE PARISH OF ST. TAMMANY HEREBY ORDAINS: that St. Tammany Parish Government, through the Office of the Parish President, is authorized to acquire, whether by donation or for no greater than fair market value as determined by appraisal, all that certain temporary construction servitude depicted on the plan attached hereto; and

BE IT FURTHER ORDAINED: that pursuant to all applicable provisions of law, the Office of the Parish President is directed and authorized to do whatever is necessary to acquire the temporary construction servitude; and

BE IT FURTHER ORDAINED: that any and all actions taken by the Office of the Parish President in furtherance of the actions contemplated herein are ratified and accepted accordingly.

REPEAL: All ordinances or parts of Ordinances in conflict herewith are hereby repealed.

SEVERABILITY: If any provision of this Ordinance shall be held to be invalid, such invalidity shall not affect other provisions herein which can be given effect without the invalid provision and to this end the provisions of this Ordinance are hereby declared to be severable.

EFFECTIVE DATE: This Ordinance shall become effective fifteen (15) days after adoption.

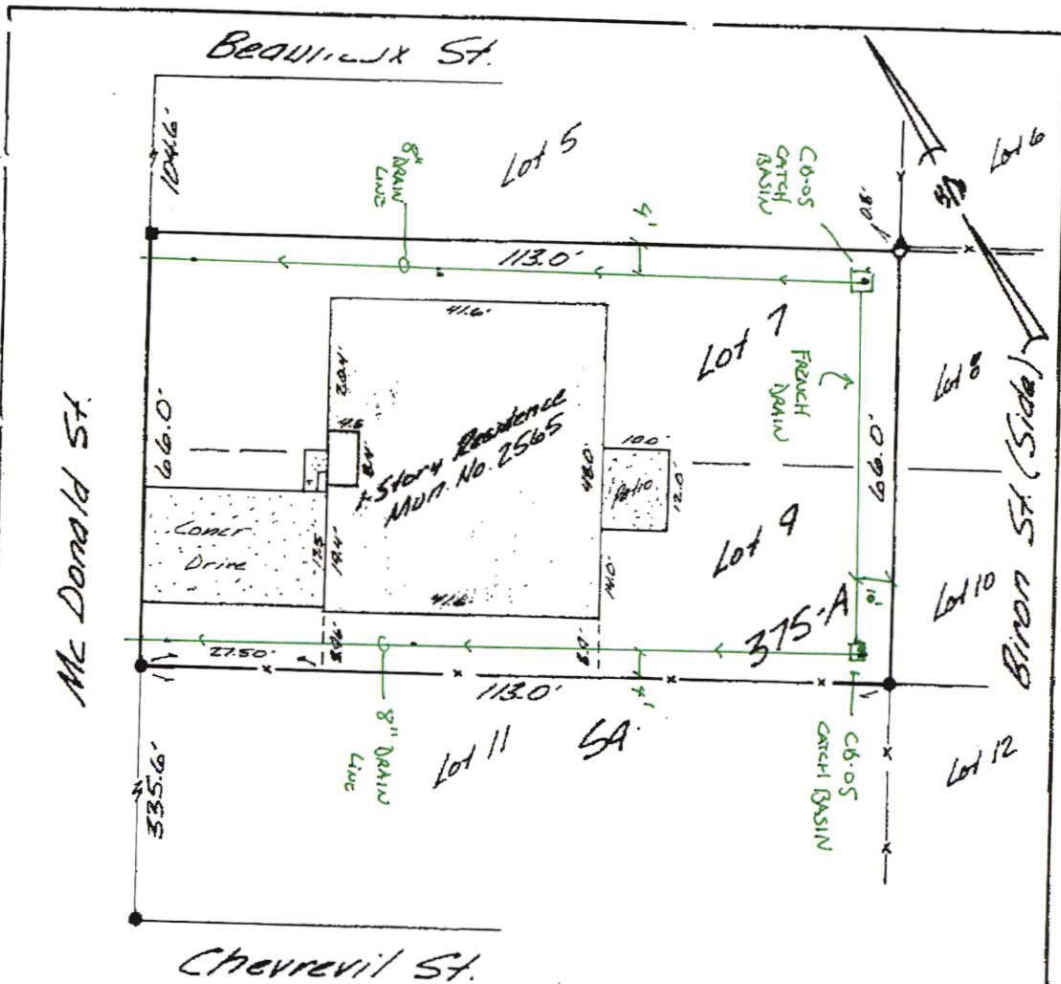
