## **Ordinance Administrative Comment**

ORDINANCE AUTHORIZING THE PARISH OF ST. TAMMANY, THROUGH THE OFFICE OF THE PARISH PRESIDENT, TO ACQUIRE CERTAIN PARCEL(S), RIGHT(S) OF WAY AND/OR SERVITUDE(S) FOR THE ABERDEEN DRAINAGE IMPROVEMENTS PROJECT (WARD 8, DISTRICT 9)

St. Tammany Parish seeks to acquire 25' drainage servitudes across the rear of Lots 9, 10 and 11 in Square 11 of Pearl Acres Subdivision as needed for the Aberdeen Drainage Improvements Project. The drainage servitudes will allow for installation of drainage improvements to facilitate the conveyance of storm water through construction of a drainage ditch to tie into the Opal Street Lateral ditch. It is contemplated that the drainage servitudes will be donated.
