AN ORDINANCE AMENDING THE OFFICIAL ZONING MAP OF ST. TAMMANY PARISH, LA, TO RECLASSIFY A CERTAIN PARCEL LOCATED ON THE NORTH SIDE OF LA HIGHWAY 40, EAST OF HOUSE CREEK ROAD, WEST OF PRESS SHARP ROAD AND WHICH PROPERTY COMPRISES A TOTAL 14.13 ACRES OF LAND MORE OR LESS, FROM ITS PRESENT A-1 (SUBURBAN DISTRICT) TO AN A1-A (SUBURBAN DISTRICT). (WARD 2, DISTRICT 2) (ZC11-09-078)

WHEREAS, the Zoning Commission of the Parish of St. Tammany after hearing in accordance with law, Case No. ZC11-09-078, has recommended to the Council of the Parish of St. Tammany, Louisiana, that the zoning classification of the above referenced area be changed from its present A-1 (Suburban District) to an A1-A (Suburban District) see Exhibit "A" for complete boundaries; and

WHEREAS, the St. Tammany Parish Council has held its public hearing in accordance with law; and

WHEREAS, the St. Tammany Parish Council has found it necessary for the purpose of protecting the public health, safety and general welfare, to designate the above described property as A1-A (Suburban District).

THE PARISH OF ST. TAMMANY HEREBY ORDAINS, in regular session convened that:

SECTION I: The zoning classification of the above described property is hereby changed from its present A-1 (Suburban District) to an A1-A (Suburban District).

SECTION II: The official zoning map of the Parish of St. Tammany shall be and is hereby amended to incorporate the zoning reclassification specified in Section I hereof.

REPEAL: All ordinances or parts of Ordinances in conflict herewith are hereby repealed.

SEVERABILITY: If any provision of this Ordinance shall be held to be invalid, such invalidity shall not affect other provisions herein which can be given effect without the invalid provision and to this end the provisions of this Ordinance are hereby declared to be severable.

EFFECTIVE DATE: This Ordinance shall become effective fifteen (15) days after adoption.

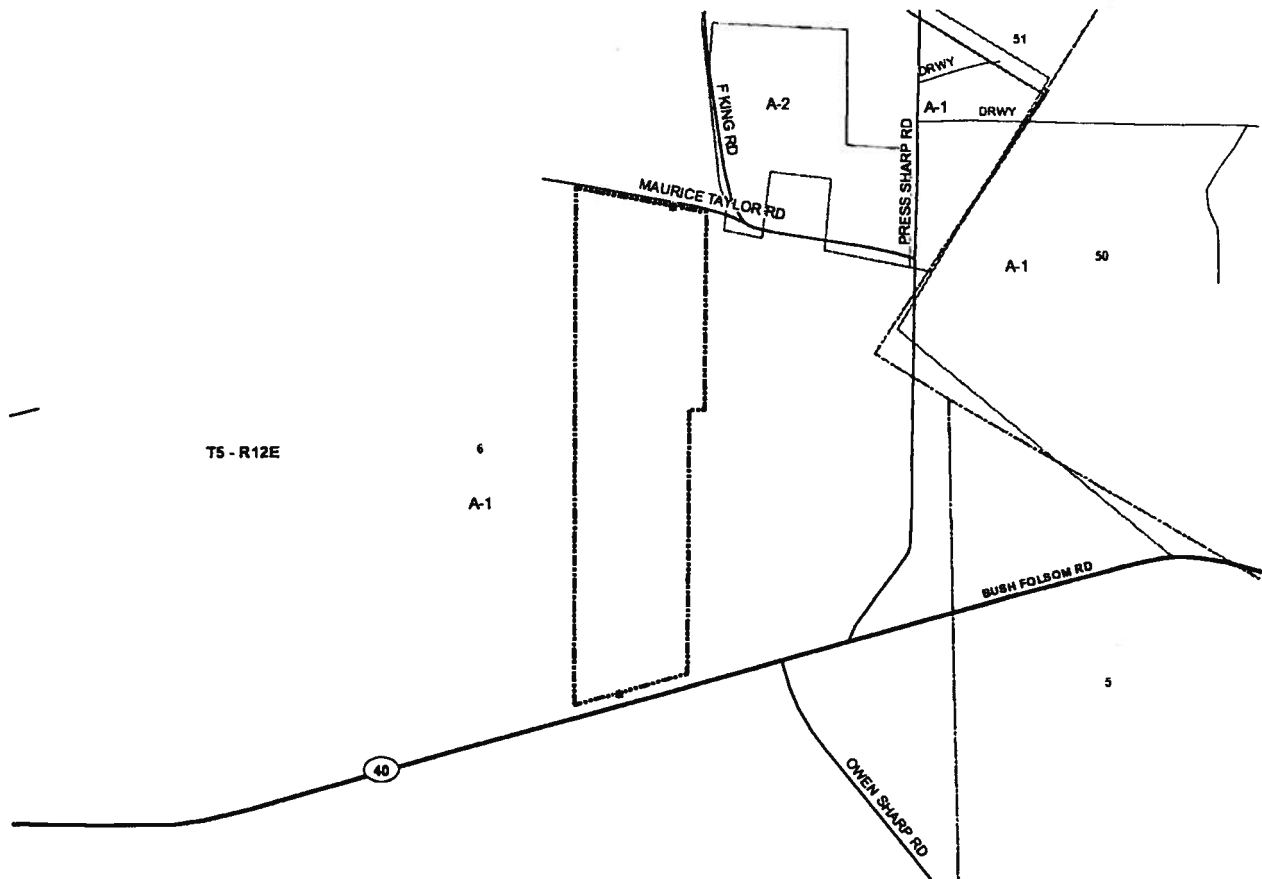
ALL THAT CERTAIN PIECE OR PORTION OF GROUND, together with all the buildings and improvements thereon, and all of the rights, ways, privileges, servitudes, appurtenances and advantages thereunto belonging or in anywise appertaining, situated in Section 6, Township 5 South, Range 12 East, St. Tammany Parish, Louisiana.

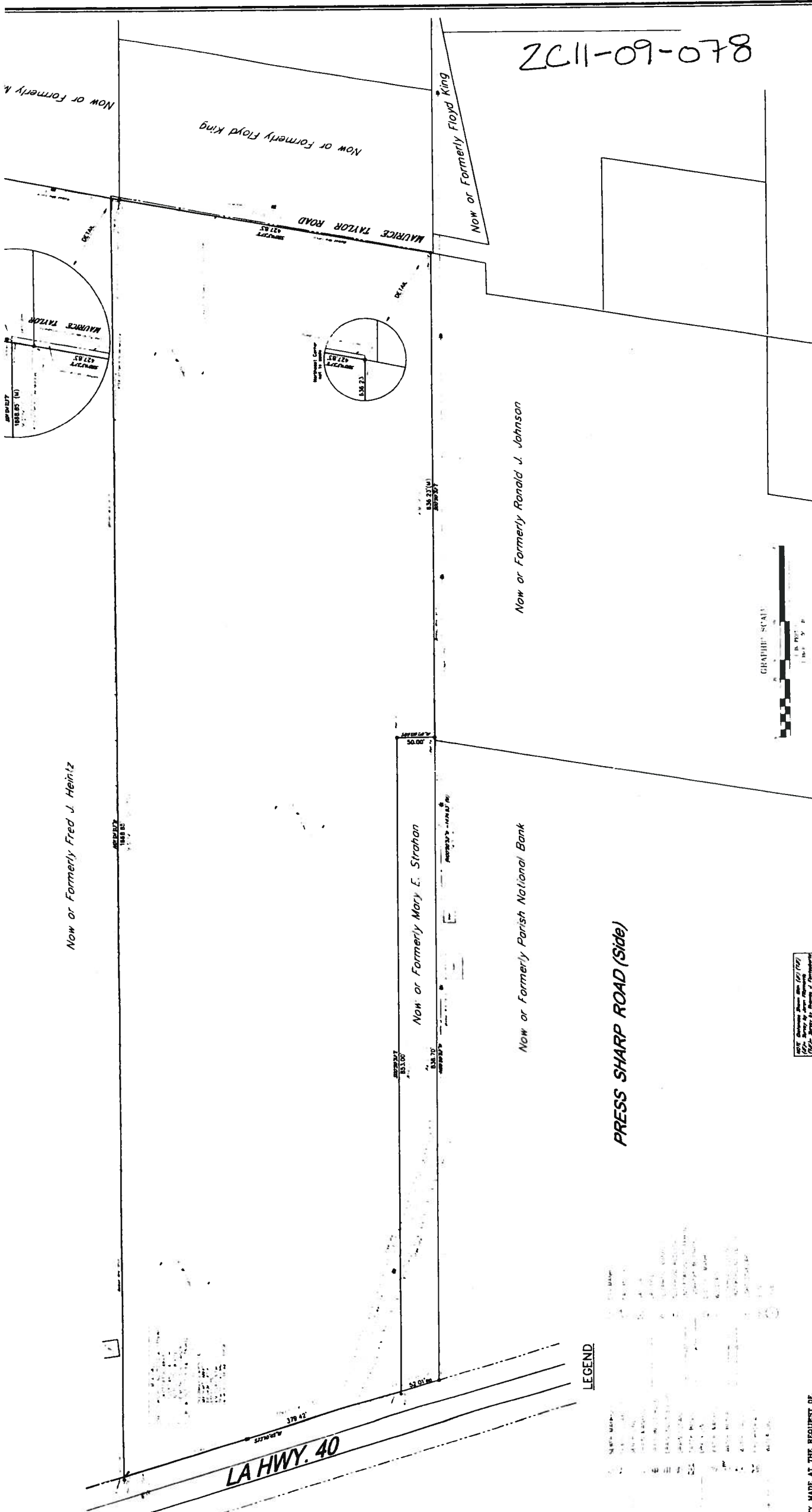
From the Quarter Corner between Sections 6 and 7, Township 5 South, Range 12 East, St. Tammany Parish, Louisiana run North 1320 feet; thence South 89 degrees 34 minutes 46 seconds East 489.61 feet; thence South 00 degrees 04 minutes 56 seconds East 401.37 feet; thence North 73 degrees 57 minutes East 772.51 feet; thence North 74 degrees 07 minutes 29 seconds East 103.96 feet to the Point of Beginning.

From the Point of Beginning run North 00 degrees 11 minutes 06 seconds West 1672.54 feet to a point; thence South 79 degrees 26 minutes 16 seconds East 427.83 feet to a point; thence South 636.04 feet to a point; thence West 50.0 feet to a point; thence South 854.22 feet to a point on the North right of way of La Highway 40; thence run along said right of way South 74 degrees 07 minutes 29 seconds West 379.66 feet back to the Point of Beginning.

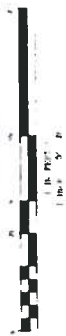
MAURICE TAYLOR ROAD
