ORDINANCE TO CORRECT THE ROAD AND DRAINAGE INVENTORY TO INCLUDE A PORTION OF FORD STREET; LEE SETTLEMENT ROAD LATERAL; OLD BARKER ROAD LATERAL; CYPRESS DRIVE; STEWART ROAD LATERAL; PEYTON'S PLACE AND JAN SMITH DRIVE. (WARDS 2, 3, & 6) (DISTRICTS 2, 3, & 6)

WHEREAS, the St. Tammany Parish Selective Road and Drainage Inventories require updating/amending periodically to provide for corrections/additions/deletions to the road and drainage inventories based upon the recommendation of the Department of Engineering, Director of Public Works, 911 Facilitator, or Certificate of Road and/or Drainage Maintenance by Area Foreman; Act of Exchange and/or Act of Donation.

THE PARISH OF ST. TAMMANY HEREBY ORDAINS: that

SECTION I: The St. Tammany Parish Selective Road and Drainage Maintenance System Inventory is amended as follows:

1. Add a portion of Ford Street (R06O014), approximately 572 feet, located south from Snead Drive to Bobby Jones Drive, Ward 6, District 6; and
2. Add Lee Settlement Road Lateral approximately 1,900 feet, located south then west from Lee Settlement Road (R02F007), Ward 2, District 3; and
3. Add Old Barker Road Lateral, approximately 650 feet, located north from Old Barker Road (R02O021), Ward 2, District 2; and
4. Add Cypress Drive, approximately 1,050 feet, located southeast from Lee Settlement Road (R02F007), Ward 2, District 3; and
5. Add an extension to Stewart Road Lateral (D03EW02012), approximately 9,000 feet, Ward 3, District 3; and
6. Add Peyton's Place, approximately 1,940 feet, located west from Jessie Hyatt Road, Ward 2, District 2; and
7. Add Jan Smith Drive, approximately 1,350 feet, runs east from Highway 1129, Ward 2, District 2.

SECTION II: The Department of Public Works is directed to obtain, place, and/or remove the appropriate streets signs as necessary to effectuate said amendments.

REPEAL: All ordinances or parts of Ordinances in conflict herewith are hereby repealed.

SEVERABILITY: If any provision of this Ordinance shall be held to be invalid, such invalidity shall not affect other provisions herein which can be given effect without the invalid provision and to this end the provisions of this Ordinance are hereby declared to be severable.

EFFECTIVE DATE: This Ordinance shall become effective fifteen (15) days after adoption.
