AN ORDINANCE ESTABLISHING A SPEED LIMIT OF 20 MPH ON ALL ROADS WITHIN THE COVINGTON COUNTRY CLUB SUBDIVISION. (WARD 1, DISTRICT 4)

WHEREAS, St. Tammany Parish government is charged with protecting the safety and general welfare of citizens of the Pariah; and

WHEREAS, the Covington Club Subdivision homeowners association has requested the speed limit within the subdivision be reduced from its present 25 mph to 20 mph; and

WHEREAS, the St. Tammany Parish Department of Engineering has issued a letter of no objection to the installation of the reduced speed limit signs.

THE PARISH OF ST. TAMMANY HEREBY ORDAINS: in regular session convened that:

SECTION I: A speed limit of 20 mph is hereby established on all roads within Covington Club Subdivision. (Ward 1, District 4)

SECTION II: The St. Tammany Parish Department of Public Works is hereby directed to replace the existing 25 mph signs with 20 mph signs as per the St. Tammany Parish Department of Engineering memo attached.

REPEAL: All ordinances or parts of Ordinances in conflict herewith are hereby repealed.

SEVERABILITY: If any provision of this Ordinance shall be held to be invalid, such invalidity shall not affect other provisions herein which can be given effect without the invalid provision and to this end the provisions of this Ordinance are hereby declared to be severable.

EFFECTIVE DATE: This Ordinance shall become effective fifteen (15) days after adoption.


- 1. Install SPEED LIMIT 20 and SLOW CHILDREN @ PLAY signs on North Dr. near the North and Service Rd. intersection.

- 3. Install SPEED LIMIT 20 sign on Pine Dr. 40' from the Pine Dr. and South Dr. intersection.
- 4. Remove Speed Limit 25 sign on Pine Dr. located near the Pine and South intersection.
- 5. Replace Speed Limit 25 sign with a SPEED LIMIT 20 sign located near the Pine and South intersection, and turn to face the correct direction.
- 6. Replace Speed Limit 25 sign with SPEED LIMIT 20 sign on South Dr. near the South and Service Rd. intersection.
- 7. Replace Speed Limit 25 sign with SPEED LIMIT 20 sign on Country Club Dr. near the Country Club and Service Rd. intersection.
- 8. Install SPEED LIMIT 20 sign on Country Club Dr. near the Country Club Dr. and Pine intersection.



- 9. Replace Speed Limit 25 sign with SPEED LIMIT 20 sign on Pine Dr. near the Pine Dr. and Country Club Dr. intersection.
- 10. Replace Speed Limit 25 sign with SPEED LIMIT 20 sign on Country Club Dr. near curve.
- 11. Remove Speed Limit 25 sign on Country Club Dr. near the curve, as indicated on map.
- 12. Install SPEED LIMIT 20 sign on Country Club Dr. 40' from the Country Club Dr. and Tchefuncte Dr. intersection.
- 13. Replace Speed Limit 25 sign with SPEED LIMIT 20 sign on Country Club Dr. near the Country Club Dr. and Tchefuncte Dr. intersection.
- 14. Install SPEED LIMIT 20 sign on Bertel Dr. 40' from the Bertel and Tchefuncte Dr. intersection.
- 15. Replace Speed Limit 25 sign with SPEED LIMIT 20 sign on Bertel Dr. located near the Bertel and Pine intersection.
- 16. Replace Speed Limit 25 sign with SPEED LIMIT 20 sign on Bertel Dr. located near the Bertel and Pine intersection.
- 17. Remove Speed Limit 25 sign on Bertel Dr. near the Bertel and Pine intersection.
- 18. Replace Speed Limit 25 sign with SPEED LIMIT 20 sign on Bertel Dr. near the Bertel and Service Rd. intersection.

- 31. Replace Speed Limit 25 sign with SPEED LIMIT 20 sign on Pine Dr. near the Pine and Tchefuncte intersection.
- 32. Replace Speed Limit 25 sign with SPEED LIMIT 20 sign on Tchefuncte Dr. near the Tchefuncte and Service Rd. intersection.
- 33. Replace Speed Limit 25 sign with SPEED LIMIT 20 sign on Camellia Dr. near the Camellia and Service Rd. intersection and Add Slow Children @ Play sign.
- 34. Install SPEED LIMIT 20 sign on Willow Dr. near the Willow and Service Rd. intersection.


## Figure 2A-2. Examples of Heights and Lateral Locations of Sign Installations
