AN ORDINANCE TO CORRECT THE ROAD & DRAINAGE INVENTORY TO INCLUDE SPRINGWOOD DRIVE LATERAL; TWO (2) RAMBLEWOOD DRIVE LATERALS; AND BUCK RUN LATERAL. WARDS 3 & 9, DISTRICTS 2 & 9

WHEREAS, the St. Tammany Parish Selective Road and Drainage Inventories require updating/amending periodically to provide for corrections/additions/deletions to the road and drainage inventories based upon the recommendation of the Department of Engineering, Director of Public Works, 911 Facilitator, or Certificate of Road and/or Drainage Maintenance by Area Foreman; Act of Exchange and/or Act of Donation.

THE PARISH OF ST. TAMMANY HEREBY ORDAINS: that the St. Tammany Parish Selective Road and Drainage Maintenance System Inventory is amended as follows:

1. Include Springwood Drive Lateral (D03HW01008). approximately 950 feet, located north of Springwood Drive (R03H008), Ward 3, District 2;
2. Include Ramblewood Drive Lateral (D03HW01010), approximately 1,500 feet, located off Ramblewood Drive (R03H010), Ward 3, District 2;
3. Include Ramblewood Drive Lateral (D03HW02010), approximately 350 feet, located off Ramblewood Drive (R03H010), Ward 3, District 2; and
4. Include Buck Run Lateral (D09IW03039), approximately 200 feet, located off Buck Run (R09I039), Ward 9, District 9.

BE IT FURTHER ORDAINED, that the Department of Public Works is directed to obtain, place, and/or remove the appropriate streets signs as necessary to effectuate said amendments.

REPEAL: All ordinances or parts of Ordinances in conflict herewith are hereby repealed.

SEVERABILITY: If any provision of this Ordinance shall be held to be invalid, such invalidity shall not affect other provisions herein which can be given effect without the invalid provision and to this end the provisions of this Ordinance are hereby declared to be severable.
