Administrative Comment Amendment No. 11 - 2017 Operating Budget - October 2017

028 - CRIMINAL COURT FUND

To amend the budget to decrease revenues and expenditures by \$348,000 to include only the receipt of funds transmitted to the Parish in accordance with the sharing percentages based on Louisiana Revised Statute 15:571.11. Historically, the total collection for fines and forfeitures was recorded as revenue, and the portion of the funds remitted by the Sheriff to the District Attorney and Sheriff's General Fund were recorded as expenditures.

To amend the budget to increase expenditures by \$20,000 for sanity hearings and \$10,000 for interpreters, as requested by the Court Administrator and the First Assistant District Attorney.
