A RESOLUTION APPROVING THE HOLDING OF AN ELECTION IN FIRE PROTECTION DISTRICT NO. 5, PARISH OF ST. TAMMANY, STATE OF LOUISIANA, ON SATURDAY, MARCH 24, 2018, TO AUTHORIZE THE LEVY OF A SPECIAL TAX THEREIN.

WHEREAS, the Board of Commissioners of Fire Protection District No. 5, Parish of St. Tammany, State of Louisiana (the "Governing Authority"), acting as the governing authority of Fire Protection District No. 5, Parish of St. Tammany, State of Louisiana (the "District"), plans to call a special election in the District on Saturday, March 24, 2018, to authorize the levy of a special tax therein; and

WHEREAS, the governing authority of the District has requested that this Parish Council, acting as the governing authority of the Parish of St. Tammany, State of Louisiana, give its consent and authority for the District to hold the aforesaid election, and in the event that the election carries for further authority to continue to levy the special tax therein; and

WHEREAS, as required by Article VI, Section 15 of the Constitution of the State of Louisiana of 1974, it is now the desire of this Parish Council to approve the holding of said election and in the event that the election carries, to continue to the levy and collect the special tax provided for therein.

NOW, THEREFORE, BE IT RESOLVED by the Parish Council of the Parish of St. Tammany, State of Louisiana, acting as the governing authority of said Parish, that:

SECTION 1. In compliance with the provisions of Article VI, Section 15 of the constitution of the State of Louisiana of 1974, and in accordance with the request of the Board of Commissioners of Fire Protection District No. 5, Parish of St. Tammany, State of Louisiana, this Parish Council hereby approves the holding of an election in the District, on Saturday, March 24, 2018, at which election there will be submitted the following proposition, to-wit:

PROPOSITION
(MILLAGE RENEWAL)

Shall Fire Protection District No. 5, Parish of St. Tammany, State of Louisiana (the "District") levy a special tax of nineteen and fifty-eight hundredths (19.58) mills on all property subject to taxation in the District (an estimated \$ 587,400 reasonably expected at this time to be collected from the levy of the tax for an entire year), for a period of ten (10) years, beginning with the year 2020 and ending with the year 2029, for the purpose of acquiring, constructing, improving, maintaining and/or operating fire protection facilities in and for the District, including equipment, and paying the cost of obtaining water for fire protection purposes, and the cost of providing services to injured or ill persons in emergency situations as permitted by law?

SECTION 2. In the event the election carries, this Parish Council does hereby further consent to and authorize the District to continue to the levy and collect the special tax provided for therein.
