AN ORDINANCE AMENDING THE ST. TAMMANY PARISH UNIFIED DEVELOPMENT CODE, CHAPTER 130, TO AMEND SECTION 130-969 RELATIVE TO PERMITTED USES IN HC-3 HIGHWAY COMMERCIAL DISTRICT TO ADD NEW PERMITTED USE (CEMETERIES).

WHEREAS, the Council of the Parish of St. Tammany, Louisiana has determined that the text of Chapter 130 St. Tammany Parish Unified Development Code Section 130-969 be amended relative to permitted uses in HC-3 Highway Commercial District to add a new permitted use "Cemeteries"; and

WHEREAS, the St. Tammany Parish Government considers that the amendment below will be advantageous to the economic development of St. Tammany Parish; and;

WHEREAS, the St. Tammany Parish Government considers that it is in the best interest of the business and citizens of St. Tammany Parish to add the use of cemeteries to the HC-3 Highway Commercial District.

THE PARISH OF ST. TAMMANY HEREBY ORDAINS, that it amends Chapter 130 St. Tammany Unified Development Code, as follow:

Amend Division 27 HC-3 Highway Commercial District specifically Section 130.969 PERMITTED USES, add a new

(14) Cemeteries

REPEAL: All ordinances or parts of Ordinances in conflict herewith are hereby repealed.

SEVERABILITY: If any provision of this Ordinance shall be held to be invalid, such invalidity shall not affect other provisions herein which can be given effect without the invalid provision and to this end the provisions of this Ordinance are hereby declared to be severable.

EFFECTIVE DATE: This Ordinance shall become effective fifteen (15) days after adoption.
