AN ORDINANCE TO CORRECT THE ROAD AND DRAINAGE INVENTORY TO INCLUDE LAKE CATHERINE DRIVE LATERAL, AND AN EXTENSION OF SHADY LANE ROAD; ALSO TO DELETE A PORTION OF ST. AMAND STREET, A PORTION OF TURQUOISE STREET, AND A PORTION OF AIRPORT ROAD LATERAL. (WARDS 1, 3, 4, 7 & 10, DISTRICTS 2, 3, 4, 6 & 11)

WHEREAS, the St. Tammany Parish Selective Road and Drainage Inventories require updating/amending periodically to provide for corrections/additions/deletions to the road and drainage inventories based upon the recommendation of the Department of Engineering, Director of Public Works, 911 Facilitator, or Certificate of Road and/or Drainage Maintenance by Area Foreman; Act of Exchange and/or Act of Donation.

THE PARISH OF ST. TAMMANY HEREBY ORDAINS: that

SECTION I: The St. Tammany Parish Selective Road and Drainage Maintenance System Inventory is amended as follows:

1. Add Lake Catherine Drive Lateral (D01EW01005), approximately 250 feet, located north from Lake Catherine Road (R01E005), Ward 1, District 3; and

2. Add an approximately 280 foot extension to Shady Lane Road (R04A013), located at the west end of the road, in Covington Country Club Estates, Ward 4, District 4; and

3. Delete a portion of St. Amand Street (R10C002), approximately 475 feet, located off Highway 59, Ward 10, District 6; and

4. Delete a portion of Turquoise Street (R07C032), approximately 685 feet, located off Amber Street, Ward 7, District 11; and

5. Delete a portion of Airport Road Lateral (D03HW03003), approximately 11,600 feet, located from the Airport Road Lateral #D03HW02003 to it's southern end, as this portion is located in the City of Covington boundaries. Ward 3, District 2.

SECTION II: The Department of Public Works is directed to obtain, place, and/or remove the appropriate streets signs as necessary to effectuate said amendments.

REPEAL: All ordinances or parts of Ordinances in conflict herewith are hereby repealed.

SEVERABILITY: If any provision of this Ordinance shall be held to be invalid, such invalidity shall not affect other provisions herein which can be given effect without the invalid provision and to this end the provisions of this Ordinance are hereby declared to be severable.

EFFECTIVE DATE: This Ordinance shall become effective fifteen (15) days after adoption.
