

## **Ordinance Administrative Comment**

ORDINANCE TO AUTHORIZE THE PARISH OF ST. TAMMANY, THROUGH THE OFFICE OF THE PARISH PRESIDENT, TO GRANT A NON-EXCLUSIVE UTILITY SERVITUDE TO WASHINGTON-ST. TAMMANY ELECTRIC COOPERATIVE, INC. ALONG HIGHWAY 1129 (LEE ROAD) AT JOHNNY F. SMITH MEMORIAL PARK. (WARD 2, DISTRICT 6) (TANNER)

Washington-St. Tammany Electric Cooperative, Inc. ("WST") has requested an electric servitude along Highway 1129/Lee Road fronting the Parish property occupied by Johnny F. Smith Memorial Park. The purpose of the servitude is to improve service reliability in the area by interconnecting substations. WST will pay fair market value based on a Parish-accepted appraised valuation.
