ORDINANCE TO AUTHORIZE ST. TAMMANY PARISH GOVERNMENT, THROUGH THE OFFICE OF THE PARISH PRESIDENT, TO ACQUIRE FULL OWNERSHIP INTEREST OF CERTAIN PROPERTY ADJUDICATED TO ST. TAMMANY PARISH FOR DRAINAGE MAINTENANCE AND/OR IMPROVEMENTS (WARD 9, DISTRICT 11)

Parish's Public Works department has identified this adjudicated property as useful for future maintenance of the Sunset Drive drainage lateral running through Woodlawn Park Subdivision.
