ORDINANCE ESTABLISHING THE PLACEMENT OF 2 STOP SIGNS AND THE RAISING AND REPLACEMENT OF THE EXISTING STOP SIGN AT THE INTERSECTION OF BOXWOOD STREET (3-J-40) AND NURSERY STREET (3-J-37). (WARD 3, DISTRICT 2)

WHEREAS, St. Tammany Parish Government is charged with protecting the safety and general welfare of citizens of the parish; and

WHEREAS, St. Tammany Parish has experienced an increase in traffic at the intersection of Boxwood St. and Nursery St., in addition to increased traffic concerns while loading and unloading of area school children from the school buses, warranting a three-way-stop intersection at the location of said roadway to assist with traffic control; and

WHEREAS, affected citizens have requested measures be taken to address this traffic control issue on a parish road.

THE PARISH OF ST. TAMMANY HEREBY ORDAINS:

SECTION I: An all-way stop intersection is established on Boxwood St. and Nursery St. (Ward 3, District 2)

SECTION II: The Parish Department of Public Works is directed to post the appropriate signs at this location as described in the attached memo.

SECTION III: If any provision of this ordinance shall be held to be invalid, such invalidity shall not affect any other provision herein which can be given effect without the invalid provision and to this end the provisions of this ordinance are hereby declared to be severable.

SECTION IV: All ordinances or parts of ordinances in conflict herewith are hereby repealed.

SECTION V: This ordinance shall become effective immediately upon final adoption.

REPEAL: All ordinances or parts of Ordinances in conflict herewith are hereby repealed.

SEVERABILITY: If any provision of this Ordinance shall be held to be invalid, such invalidity shall not affect other provisions herein which can be given effect without the invalid provision and to this end the provisions of this Ordinance are hereby declared to be severable.

EFFECTIVE DATE: This Ordinance shall become effective fifteen (15) days after adoption.
