RESOLUTION APPROVING AND AUTHORIZING ST. TAMMANY PARISH THROUGH THE OFFICE OF THE PARISH PRESIDENT TO SIGN AND/OR EXECUTE A COOPERATIVE ENDEAVOR AGREEMENT BETWEEN THE PARISH OF ST. TAMMANY AND THE STATE OF LOUISIANA THROUGH THE DEPARTMENT OF TRANSPORTATION AND DEVELOPMENT FOR LA 1077/LA 1085 AND BOOTLEGGERS ROAD.

WHEREAS, LA 1077 and LA 1085 are part of the State Highway System and under the jurisdiction and control of LADOTD, and Bootlegger Road is a local roadway under the jurisdiction and control of the Parish; and

WHEREAS, the Parish, LADOTD, and the Federal Highway Administration ("FHWA") will participate with one another for the installation of a roundabout at the intersection of LA 1077, LA 1085 and Bootlegger Road with raised medians extending approximately eight hundred (800') feet in each direction from the roundabout, and rehabilitation of the existing pavement and striping; and

WHEREAS, these access management improvements are intended to improve safety, increase vehicular capacity and relieve congestion when traveling along LA 1077, LA 1085 and Bootlegger Road and in the vicinity of said intersection; and

WHEREAS, the estimated cost for this Project is Two Million Three Hundred Fifty Thousand and 00/100 Dollars (\$ 2,350,000.00) to be shared jointly between the LADOTD and the FHWA; and

WHEREAS, the Parish will contribute a maximum additional amount of Three Hundred Thousand and 00/100 Dollars (\$ 300,000.00) to the Project. Said contribution will first be applied to design and preconstruction engineering costs; and

WHEREAS, the amount of Two Million Three Hundred Fifty Thousand and 00/100 Dollars (\$ 2,350,000.00) will be shared between the FHWA and LADOTD with the FHWA contributing 80%, for a total of One Million Eight Hundred Eighty Thousand and 00/100 Dollars (\$ 1,880,000.00) and the LADOTD contributing the required local match of 20% for a total of Four Hundred Seventy Thousand and 00/100 Dollars (\$ 470,000.00).

THE PARISH OF ST. TAMMANY HEREBY RESOLVES that the Parish President is hereby authorized to sign and/or execute a Cooperative Endeavor Agreement between St. Tammany Parish and the State of Louisiana through the Department of Transportation and Development regarding the objectives stated above; and

BE IT FURTHER RESOLVED that all acts previously taken by the Office of the Parish President in furtherance of the actions or agreements contemplated herein are hereby ratified and approved.
