ORDINANCE TO DECLARE A PORTION OF SQUARE 1, DITTMAR ADDITION AND SQUARE 39, ROBERT ADDITION (2598 CAREY STREET, SLIDELL) AS SURPLUS TAX-ADJUDICATED PROPERTY AND AUTHORIZE THE DONATION OF SAID PROPERTY TO THE CITY OF SLIDELL (WARD 8, DISTRICTS 12, 14).

WHEREAS, the Parish of St. Tammany owns an adjudicated tax deed to property described as a portion of Square 1, Dittmar Addition and Square 39, Robert Addition or 2598 Carey Street, Slidell (the "Property"), said property having been adjudicated to St. Tammany Parish for unpaid property taxes; and

WHEREAS, the City of Slidell has identified the Property as being adjacent to the Greenwood Cemetery and desirable to Slidell; and

WHEREAS, Parish desires to donate the Property to the City of Slidell for Slidell's use in accordance with the disposition of adjudicated property procedures provided by Louisiana Revised Statutes Section 47:2196, et seq. and also as authorized by Louisiana Revised Statutes Section 47:2205 and Louisiana Revised Statutes Section 33:1321, et seq.

THE PARISH OF ST. TAMMANY HEREBY ORDAINS: that the tax adjudicated portion of Square 1, Dittmar Addition and Square 39, Robert Addition (2598 Carey Street, Slidell) is surplus property

BE IT FURTHER ORDAINED: that the Parish Council authorizes the donation of the Property to the City of Slidell in accordance with the disposition of adjudicated property procedures provided by Louisiana Revised Statutes Section 47:2196, et seq.

BE IT FURTHER ORDAINED: that the Parish President is authorized to sign any and all documents necessary to effectuate the donation to the City of Slidell.

REPEAL: All ordinances or parts of Ordinances in conflict herewith are hereby repealed.

SEVERABILITY: If any provision of this Ordinance shall be held to be invalid, such invalidity shall not affect other provisions herein which can be given effect without the invalid provision and to this end the provisions of this Ordinance are hereby declared to be severable.

EFFECTIVE DATE: This Ordinance shall become effective fifteen (15) days after adoption.
