Administrative Comment Amendment No. 9 - 2019 Operating Budget - August 2019

This budget amendment is to:

a. 127 - ST. TAMMANY PARISH JAIL FUND

To amend the budget to increase revenue and expenditures by \$40,000 for back tax collected by tax collector and transferred to the St. Tammany Parish Sheriff's Office for jail operations.

b. 502 - UTILITY OPERATIONS FUND

To amend the budget to increase expenditures by \$50,000 for overtime for scheduled and emergency events, \$40,000 for additional costs for fire hydrant repair/replacement, \$100,000 for warehouse water system supplies, and \$200,000 for the Northlake Behavioral WWTP Upgrade Capital Project.
