RESOLUTION TO ACKNOWLEDGE THE AUTHORITY PURSUANT TO HOME RULE CHARTER SECTIONS 1-04, 3-01 AND 3-09 FOR ST. TAMMANY PARISH GOVERNMENT, THROUGH THE OFFICE OF THE PARISH PRESIDENT, TO EXECUTE A COOPERATIVE ENDEAVOR AGREEMENT WITH START CORPORATION FOR OPERATION OF GROUP HOMES ON THE SAFE HAVEN CAMPUS (WARD 4, DISTRICT 7)

WHEREAS, St. Tammany Parish Government owns two (2) group homes on the Safe Haven Campus, each capable of housing six (6) individuals each (the "Group Homes"); and

WHEREAS, Start Corporation desires to use the Group Homes for transitional and less restrictive mental health residential facilities and outpatient treatment programs for persons suffering from mental or behavioral health related issues; and

WHEREAS, Parish desires for Start Corporation to occupy and utilize the Group Homes to support the provision and management of health care delivery systems and clinical services relative to mental health and substance abuse disorders at Safe Haven.

THE PARISH OF ST. TAMMANY HEREBY RESOLVES that St. Tammany Parish Government, through the Office of the Parish President pursuant to Home Rule Charter Sections 1-04, 3-01 and 3-09 is authorized to enter into a Cooperative Endeavor Agreement, which meets or exceeds all of the requirements of Louisiana law and jurisprudence, with Start Corporation for the operation of two group homes on the Safe Haven Campus.

BE IT FURTHER RESOLVED that all actions previously taken by the Office of the Parish President in furtherance of the agreements contemplated herein are hereby ratified and approved.

Parish seeks to enter into a Cooperative Endeavor Agreement with Start Corporation to provide for operation of two group homes on the Safe Haven Campus. In exchange for use of the buildings, Start Corporation shall operate a transitional group home operation for up to twelve adults and provide for all maintenance and upkeep.
