AN ORDINANCE TO CORRECT THE ROAD AND DRAINAGE INVENTORY TO INCLUDE ARCHIE SINGLETARY ROAD LATERAL; 2 LYNN DRIVE LATERALS; HERMAN SINGLETARY ROAD LATERAL; RHEUSAW PARKER ROAD LATERAL; GRETCHEN LANE LATERAL; SYCAMORE PLACE LATERAL; KISSENA PARK COURT LATERAL; AND AN EXTENSION TO CARNATION STREET WARDS 3, 4, 6 & 10, DISTRICTS 3, 6, 7 & 11

WHEREAS, the St. Tammany Parish Selective Road and Drainage Inventories require updating/amending periodically to provide for corrections/additions/deletions to the road and drainage inventories based upon the recommendation of the Department of Engineering, Director of Public Works, 911 Facilitator, or Certificate of Road and/or Drainage Maintenance by Area Foreman; Act of Exchange and/or Act of Donation.

THE PARISH OF ST. TAMMANY HEREBY ORDAINS: that the St. Tammany Parish Selective Road and Drainage Maintenance System Inventory is amended as follows:

1. Add Archie Singletary Road Lateral (#D06HW03005), approximately 1,400 feet, located north off Archie Singletary Road (R06H005), Ward 6, District 6; and

2. Add Lynn Drive Lateral (# D06GW02020), approximately 500 feet, located southwest from Lynn Drive (R06G020), Ward 6, District 11; and

3. Add Lynn Drive Lateral (# D06GW03020), approximately 500 feet, located southwest from Lynn Drive (R06G020), Ward 6, District 11; and

4. Add Herman Singletary Road Lane Lateral (#D06IW01015), approximately 1,000 feet, located north from Herman Singletary Road (R06I015), Ward 6, District 6; and

5. Add Rheusaw Parker Road Lateral (#D06IW02001), approximately 800 feet, located south from Rheusaw Parker Road (R06I001), Ward 6, District 6; and

6. Add Gretchen Lane Lateral (#D03DW01025), approximately 210 feet, located north from Gretchen lane (R03D025), Ward 3, District 3; and

7. Add Sycamore Place Lateral (#D04EW05120), approximately 220 feet, located south from Sycamore Place (R04E120), Ward 4, District 7; and

8. Add Kissena Park Court Lateral (#D10DW02021), approximately 10,820 feet, located east from Kissena Park Court (R10D021), Ward 10, District 6; and

9. Add an approximate 700 feet extension to Carnation Street (R10D016), Ward 10, District 6.

BE IT FURTHER ORDAINED, that the Department of Public Works is directed to obtain, place, and/or remove the appropriate streets signs as necessary to effectuate said amendments.

REPEAL: All ordinances or parts of Ordinances in conflict herewith are hereby repealed.

SEVERABILITY: If any provision of this Ordinance shall be held to be invalid, such invalidity shall not affect other provisions herein which can be given effect without the invalid provision and to this end the provisions of this Ordinance are hereby declared to be severable.

EFFECTIVE DATE: This Ordinance shall become effective fifteen (15) days after adoption.
