

AMENDMENT TO COOPERATIVE ENDEAVOR AGREEMENT BETWEEN
LOUISIANA DEPARTMENT OF AGRICULTURE AND FORESTRY
AND THE ST. TAMMANY PARISH GOVERNMENT

(Nuisance Feral Swine Control Program)

This Amendment to Cooperative Endeavor Agreement (the "Amended CEA") is made and entered into effective December 23, 2015, by and between the following parties:

ST. TAMMANY PARISH GOVERNMENT, a political subdivision of the State of Louisiana, whose mailing address is P.O. Box 628, Covington, Louisiana, 70434, herein appearing by and through Patricia P. Brister, its Parish President, duly authorized by law (hereinafter referred to as "Parish");

THE LOUISIANA DEPARTMENT OF AGRICULTURE AND FORESTRY (hereinafter referred to as "LDAF"), an agency of the State of Louisiana, herein represented by Mike Strain, DVM, Commissioner of Agriculture and Forestry; and

THE ST. TAMMANY PARISH RECREATION DISTRICT NO. 1, a political subdivision of the State of Louisiana, whose mailing address is 63350 Pelican Drive, Mandeville, LA 70448, represented by and through Nixon Adams, Chairman of the Board of Commissioners, duly authorized (hereinafter referred to as RD#1).

WHEREAS, effective December 23, 2015, Parish and LDAF entered into that Cooperative Endeavor Agreement (the "Original CEA") wherein LDAF agreed to provide trapping and removal services to control the population of nuisance feral swine residing on certain immovable property owned by the Parish, plus other obligations as more fully described in the Original CEA; and

WHEREAS, the parties have identified a need to amend the Original CEA to clarify the ownership interests in the immovable property made the subject of the Original CEA and to add RD#1 as a party to said Agreement.

AND NOW THEREFORE, the parties desire to enter into this Amended CEA to state the obligations of each party more fully herein and to amend and/or add the following provisions. This Amended CEA is not intended to release any party from the obligations stated in the Original CEA, but is intended only to amend, restate or add certain provisions to that Agreement:

1. The foregoing recitals are hereby incorporated into the body of this Amended CEA as if fully rewritten and restated herein.
2. Section I of the Original CEA is amended to read as follows:

I. OBLIGATIONS OF THE PARTIES

As agreed, the obligations to be provided by each of the parties to this agreement shall be as follows:

1. LDAF agrees to trap nuisance feral swine on three tracts of immovable property, owned in certain proportions by the St. Tammany Parish Government and The St. Tammany Parish Recreation District No. 1. Tract 1A is comprised of approximately 100.39 acres and is owned by RD#1, and Tract 1B is comprised of approximately 193.47 acres and is owned by the Parish. Tract 2 is comprised of approximately 1,442 acres and is owned by the Parish (only). The aforementioned tracts (collectively the "property") are more particularly described in "Exhibit A," attached hereto and made a part of this Agreement.
 2. LDAF will provide all equipment and labor necessary to trap and remove the nuisance feral swine.
 3. St. Tammany Parish Government and The St. Tammany Parish Recreation District No. 1 will provide LDAF with a safe path of ingress and egress to the Property. St. Tammany Parish Government and The St. Tammany Parish Recreation District No. 1 will hold LDAF harmless for any damage to the Property that may occur to person or property during ingress, egress, or during the trapping activities.
 4. LDAF will remove the nuisance feral swine from the Property. LDAF makes no guarantee as to the number of nuisance feral swine that will be trapped and removed.
 5. No compensation will be owed by St. Tammany Parish Government and/or The St. Tammany Parish Recreation District No. 1 to LDAF for the trapping of the nuisance feral swine. No compensation will be owed by LDAF to the St. Tammany Parish Government and/or The St. Tammany Parish Recreation District No. 1 for any value associated with the nuisance feral swine.
3. Section V of the Original CEA is amended to provide that any notice, demand, communication or request required or permitted under this CEA to RD#1 should be given in writing and delivered in person or by certified mail, return receipt requested, as follows:

4. Section VI(A) and VI(B) of the Original CEA are amended to read as follows:

VI. MISCELLANEOUS PROVISIONS

A. Non-Exclusivity for the Parish and RD#1. The Parish and RD#1 shall be free to engage the services of other trappers and/or persons for the performance of some or all of the obligations contemplated by this Agreement.

B. Acknowledgment of Exclusion of Worker's Compensation Coverage. The St. Tammany Parish Government and The St. Tammany Parish Recreation District No. 1 acknowledge that if any of their employees voluntarily participate in the trapping of nuisance feral swine in any way, they in no way become an employee or independent contractor of LDAF. LDAF shall not be liable to the Parish, RD#1 or their employees for any benefits or coverage as provided by the Workmen's Compensation Law of the State of Louisiana.

5. This Amended CEA supersedes the Original CEA only where there exists any conflict. This Amended CEA controls any conflicts of any terms or conditions. Except as amended hereby, the Original CEA remains unmodified and in full force and effect.
6. All capitalized terms used herein but not defined shall have the meaning assigned to them in the Original CEA.
7. This Agreement may be executed in counterparts, each of which shall be deemed an original and all of which together shall constitute one and the same instrument.
