

AMENDMENT TO COOPERATIVE AGREEMENT
(Cooperative Extension Service)

This Amendment to Cooperative Agreement (the "Amended Agreement") is made and entered into as of the dates hereinafter set forth, by and between the following parties:

ST. TAMMANY PARISH GOVERNMENT, a political subdivision of the State of Louisiana, whose mailing address is P.O. Box 628, Covington, Louisiana 70434, herein appearing by and through Patricia P. Brister, its Parish President, duly authorized by law (hereinafter referred to as "Parish"); and

LOUISIANA COOPERATIVE EXTENSION SERVICE, a political subdivision of the State of Louisiana, whose mailing address is 102 J. Norman Efferson Hall, Baton Rouge, Louisiana 70803, herein represented William B. Richardson, Vice President for Agriculture and Dean of College of Agriculture, Chalkley Family Endowed Chair and Director, Louisiana Cooperative Extension Service, LSU AgCenter (hereinafter referred to as "Extension"); and

WHEREAS, effective as of November 10, 2010, Parish and Extension entered into that Cooperative Agreement to Support and Administer Louisiana Cooperative Units Off Campus, as same has been amended (collectively, the "Original Agreement"), wherein Extension agreed to provide agricultural education and Parish agreed to provide office space and operating services support, plus other obligations of both parties as more fully described in the Original Agreement; and

WHEREAS, the parties have identified a need to amend the Original Agreement to extend the term and to provide for funding for calendar year 2019, and/or as related to other obligations set forth in the Original Agreement.

AND NOW THEREFORE, the parties desire to enter into this Amended Agreement in order to state each parties' obligations more fully herein and desire to amend and/or add the following provisions. This Amended Agreement is not intended to release any party from the obligations stated in the Original Agreement, but is intended only to amend certain provisions to that Agreement:

1. The foregoing recitals are hereby incorporated into the body of this Amended Agreement as if fully rewritten and restated herein.
2. The unnumbered section entitled "Implementation" of the Original Agreement is amended and restated as follows:

Parish and Extension hereby extend the term of the Agreement for a one (1) calendar year period beginning January 1, 2019 and expiring December 31, 2019.

3. Section 3 of the section entitled "The Parish Agrees:" of the Original Agreement is amended and restated as follows:
 3. Provide a maximum of Thirty Thousand Five Hundred Seventeen and no/100 (\$30,517.00) Dollars for the 2019 calendar year for salary support and associated fringe benefits for local faculty members and pro-rata classified local staff affiliated with the LSU AgCenter. Said amount shall be payable to Extension in two (2) installments of Fifteen Thousand Two Hundred Fifty Eight and 50/100 (\$15,258.50) Dollars.
4. This Amended Agreement supersedes the Original Agreement only where there exists any conflict. This Amended Agreement controls any conflicts of any terms or conditions. Except as amended hereby, the Original Agreement remains unmodified and in full force and effect.
5. All capitalized terms used herein but not defined shall have the meaning assigned to them in the Original Agreement.
