

**AMENDMENT TO COOPERATIVE ENDEAVOR AGREEMENT**  
(Mandeville Bypass Road)

This Amendment to Cooperative Endeavor Agreement (the "Amended CEA") is made and entered into by and between the following parties:

**ST. TAMMANY PARISH GOVERNMENT**, a political subdivision of the State of Louisiana and the governing authority of St. Tammany Parish, whose mailing address is P.O. Box 628, Covington, Louisiana 70434, herein appearing by and through Patricia P. Brister, Parish President, duly authorized (hereinafter referred to as "Parish"); and

**THE CITY OF MANDEVILLE**, a political subdivision of the State of Louisiana, whose mailing address is 3101 East Causeway Approach, Mandeville, Louisiana 70448, represented by and through Donald J. Villere, Mayor, duly authorized (hereinafter referred to as "City").

**WHEREAS**, effective as of April 21, 2015, Parish and City entered into that Cooperative Endeavor Agreement (the "Original CEA"), wherein City agreed to provide funding towards Parish's design, engineering and/or construction of the Project; and

**WHEREAS**, the parties have identified a need to amend the Original CEA to acknowledge an extension of the Term and the Project costs that City will contribute funds towards; and

**NOW THEREFORE** the parties desire to enter into this Amended CEA in order to amend and/or add the following provisions. This Amended CEA is not intended to release any party from the obligations stated in the Original CEA, but is intended only to amend certain provisions to that agreement:

1. The foregoing recitals are hereby incorporated into the body of this Amended CEA as if fully rewritten and restated herein.
2. Section 4.1 of the Original CEA is amended and restated to read as follows:

**4.1** The term of this Agreement shall commence at full execution and extend for the performance period of the Project (a) through acceptance of the Mandeville Bypass Road and close-out or (b) six (6) years following the date of full execution of this Agreement, whichever occurs earlier (the "Term").

3. This Amended CEA supersedes the Original CEA only where there exists any conflict. This Amended CEA controls any conflicts of any terms or conditions. Except as amended hereby, the Original CEA remains unmodified and in full force and effect.

4. All capitalized terms used herein but not defined shall have the meaning assigned to them in the Original CEA.

**THUS DONE AND SIGNED** in multiple original counterparts, to be executed simultaneously in two or more counterparts, each of which shall be deemed an original and all of which together shall constitute one in the same instrument.
