

AMENDMENT TO COOPERATIVE ENDEAVOR AGREEMENT

This Amendment to Cooperative Endeavor Agreement (the "Amended Agreement") is made and entered into as of the dates hereinafter set forth, by and between the following parties:

ST. TAMMANY PARISH GOVERNMENT, a political subdivision of the State of Louisiana, whose mailing address is P.O. Box 628, Covington, Louisiana, 70434, herein appearing by and through Patricia P. Brister, its Parish President, duly authorized by St. Tammany Parish Home Rule Charter sections 1-04, 1-06, 3-01 and 3-09 (hereinafter referred to as "Parish"); and

THE CITY OF SLIDELL, a municipality of the State of Louisiana, whose mailing address is 2055 Second Street, Slidell, Louisiana 70458, represented by and through Freddy Drennan, Mayor, duly elected and authorized, as per law (hereinafter referred to as "City"); and

WHEREAS, effective as of September 14, 2004, Parish and City entered into that Cooperative Endeavor Agreement recorded as Instrument No. 1455469 (the "Original Agreement"), wherein City donated certain sewage treatment equipment to Parish and Parish provided certain rights-of-way, plus other obligations of both parties as more fully described in the Original Agreement; and

WHEREAS, the parties have identified a need to amend the Original Agreement to add the ability of City to install and maintain water lines along certain rights-of-way along the Tammany Trace.

AND NOW THEREFORE, the parties desire to enter into this Amended Agreement in order to state each parties' obligations more fully herein and desire to amend and/or add the following provisions. This Amended Agreement is not intended to release any party from the obligations stated in the Original Agreement, but is intended only to amend certain provisions to that Agreement:

1. The foregoing recitals are hereby incorporated into the body of this Amended Agreement as if fully rewritten and restated herein.
2. Section (4) of the Original Agreement is hereby amended and restated as follows:

"(4) St. Tammany hereby ratifies its previously given permission whereby the City of Slidell was allowed to use certain rights-of-way along Tammany Trace to install and maintain sewerage and water lines;"

3. This Amended Agreement supersedes the Original Agreement only where there exists any conflict. This Amended Agreement controls any conflicts of any terms or

conditions. Except as amended hereby, the Original Agreement remains unmodified and in full force and effect.

4. All capitalized terms used herein but not defined shall have the meaning assigned to them in the Original Agreement.
