Sealed bids will be received by the Department of Procurement, until **2:00 p.m., Thursday, November 4, 2021,** and then opened and read publicly at that time by the Procurement Staff for the following project:

Each paper bid must be submitted in a sealed envelope. The outside of the envelope shall show the Name and Address of the Bidder, the State Contractor's License Number of the Bidder (if the work is estimated at \$50k or more), the Bid Name and the Bid Number.

It is the Vendor's responsibility to check the Parish website or bid express frequently for any possible addenda that may be issued. The Parish is not responsible for a Vendor's failure to download any addenda documents required to complete a submission.

Prices remain in effect from January 1, 2022, through December 31, 2022, with the option to extend for two (2) additional one-year renewals, by written agreement of both parties. Any delivery or service charge must be included in the bid price. Quantities may vary; minimum orders shall not be required. St. Tammany Parish Government reserves the right to award materials in whole, in part, and/ or to multiple vendors.

PRICING

Price per ton for asphalt FOB Parish trucks at the plant, as may be required from time to time in the maintenance and construction of Parish roads within the Parish. Bids are to be made on such materials according to the 2006 DOTD Blue Book and standard specifications used by the Parish. Bids must be submitted on the Pricing Sheet provided. All Price blank spaces must be filled in, NO blanks will be permitted. If the item is unavailable, or you are not bidding on the item, please enter N/A or No Bid.

MATERIAL AVAILABILITY

Bidders must be in a position to furnish Asphaltic Mixture for Hot Application as requested by the Parish's Department of Public Works (DPW). It will be the responsibility of bidders to give the DPW a forty-eight (48) hour notice as to when the plant will be out of operation and/or is not processing the Asphaltic Mixture for Hot Application presented in these specifications.

BASIS OF AWARD

Orders for asphaltic mixture for hot application shall be awarded to the bidder(s) closest to the job site based upon the unit price bid. This determination of award is being made due to the amount of waste product realized when traveling excessive distances with hot mix. It has been determined that this practice is in the best interest of the Parish. Bids must be submitted on a per ton basis.
