The St. Tammany Parish Government Parish (Parish) Department of Animal Services routinely provides care and medical attention to a variety of animals. It is the intent of the Parish to secure pricing on Medical Supplies for use by St. Tammany Parish Government Animal Services Department. Items will be ordered on an “as needed” basis.

Delivery Location: Department of Animal Services 31078 Hwy 36, Lacombe, LA 70445.

Prices remain in effect through **December 31, 2022**, with option to extend for one (1) additional year, by written agreement of both parties. Any delivery or service charge must be included in the bid price. Quantities may vary; minimum orders shall not be required.

The Parish reserves the right to award materials in whole, in part and/ or to multiple vendors. Bids must be submitted on the Pricing Sheet provided. **All fields must be filled in, NO blanks will be permitted. If the item is unavailable, enter N/A.**

A Corporate Resolution or other written evidence of authority of the person signing the bid must be provided with your bid at the time of submission in order to be deemed responsive.

- Other written evidence may Include:
 - Written evidence of corporate officer in current annual report.
 - Written evidence of members in partnership, LLC, LLP or other legal entity in most current business records on file with Louisiana Secretary of State.
 - Certification of Authority by legal entity.
 - Affidavit, Resolution, or other acknowledged or authenticated document listing names of all parties authorized to submit public bids on file with Louisiana Secretary of State.

All products shall be new and of current manufacture. Where specified on the bid sheets, prices shall be for the approved brand or a prior approved equal by the Parish. Where the bid sheet does not indicate an approved brand for an item, the Parish has no preference. The name of any manufacturer mentioned in the specifications is for the purpose of establishing a minimum acceptable standard of quality desired by the Parish. On all items bid, the Bidder shall indicate clearly the product being bid and, where applicable, shall supply catalog cuts and descriptive literature with the original copy of the bid. All products bid must have prior approval as “approved equivalents”.

Should the Bidder desire to submit inquiries and/or request approval of an alternative product, Bidder shall submit brand(s) and specifications of the alternative product to the Procurement Department via email to purchasing@stpgov.org, within seven (7) business days prior to the bid opening. The Parish shall review the inquiry and/or request for “approved equivalent” and issue an addendum within three (3) business days prior to the bid opening if prior approval submission is accepted as equivalent.
