The contractor shall provide all labor, materials and equipment necessary to remove and replace five (5) concrete road panels on Riviera Dr. and nine (9) concrete road panels and 115'4" of 6" x 6" barrier curb on St. Andrews Ct.

Specifications for the concrete panels and curbs are as follows:

Concrete road panels are 8" thick and shall be constructed with 4000 PSI concrete and doweled into adjoining panels with 5/8th bars 24" on center. The contractor shall level and repair base as directed by inspector. Repaired areas are to receive A-4 select. All work shall be done in accordance with LA DOTD Standard Specifications for Roads and Bridges, Section 602. The contractor shall replace and seal joints in kind, ie, construction or expansion joints. Work shall include all necessary saw cuts to adjoining panels to allow removal of panels to be replaced without damaging the adjoining panel and removal of temporary asphalt patch. Panel to be removed will be marked with orange paint by inspector. All debris is to be removed at no direct pay

Concrete barrier curbs are to be 6" tall by 6" wide and constructed with 4000 PSI concrete. Work shall be done in accordance with the LA DOTD Standard Specifications for Roads and Bridges, Section 707. Work shall include all necessary saw cuts to remove curb. Asphalt impregnated fiber board shall be installed in control joints that are located above a road panel construction and expansion joints. Curbs to be replaced will be marked in paint by the inspector. All debris is to be removed at no direct pay.

The contractor will have 30 days to complete the project from the date stated in the Notice to Proceed issued by the Parish.
