Can a Waiver that is not notarized be submitted in the proposal? Are sub consultants required to submit Acknowledgement of Waivers or is only the prime required?

- Question 5. Section 5.26 Are insurance certificates required to be included in the submittal? Are insurance certificates from the sub consultants required to be included in the submittal?
