QUESTIONS & ANSWERS:

- **Question #1:** Who is the current provider?
- Answer #1: The current provider is Waste Management.
- **Question #2:** What is the current service level (once/twice a week MSW/Bulk/REC)?
- Answer #2: The current service level is MSW Twice Weekly, Bulk Once Weekly, and REC Once per week.
- **Question #3:** What is the rate that the Parish pays for that service?
- **Answer #3:** The rate the Parish pays is \$18.90 per month.
- **Question #4:** Will the Parish accept alternative proposals?
- **Answer #4:** The Parish will not allow alternate proposals.
- **Question #5:** Is there a specific number of originals and copies the Proposer must submit for this RFP?

- **Answer #5:** Yes, please refer to Section 1.5 N for clarification.
- **Question #6:** What is the award date of the contract?
- **Answer #6:** The contract period will be effective starting February 1, 2020.
- Question #7: Will final scoring be disclosed to respondents to this RFP before the award date?
- Answer #7: Yes, the final scoring results will be posted to the Parish website.
- **Question #8:** Section 2.1, Type of Collection of the RFP document references Cart/Container size. The document states that Cart/Container shall have a capacity of at least 64 gallons but not more than 96 gallons. Does this requirement only relate to the garbage carts? Currently, Garbage District 1 residents have a 96-gal cart for garbage and 18-gal bin for recycling?
- Answer #8: 64 gallon to 96 gallon carts refers only to the MSW. Per the definitions section: Recycle Bin: A receptacle with a capacity.
- **Question #9:** Section 5.6, Performance Bond of the RFP documents references Performance (Surety) bond. Will proposers be required to provide a bid bond?
- Answer #9: Please refer to General Information #1 of this addendum.
