Price per ton, scale ticket required, FOB Parish Trucks, pit site, for surface course aggregates, sand clay gravel, sands, pea gravel, road gravel clay and fill dirt (road gravel: deleterious material not allowed, i.e. sticks, clay balls, etc.) (sand: A-4 Select) as may be required from time to time in the maintenance and construction of Parish roads within the Parish of St. Tammany. Bids are to be made on such materials according to the 2006 Edition of the State of Louisiana Department of Transportation and Development's Blue Book titled Louisiana Standard Specifications for Roads and Bridges.

Price per ton on hauling (scale tickets required for hauling and for pickup) of road materials from pit or landing place to the various road maintenance districts within the Parish.

Price per ton on truck spreading road materials on various roads within the Parish as may be required.
