PART II: SCOPE OF WORK/SERVICES

2.1 Scope of work/Services

St. Tammany Parish government seeks a contractor to provide, install and commission (9) ASI ASIC/3 Controllers to Safe Haven Quad "B" (23363 South Robin Road, Mandeville, LA 70448) and integrate them into existing ASI Workstation located in the Mechanical Plant (23592 Sparrow Road, Mandeville, LA 70448).

The project consists of the following;

- Provide and Install (9) Brand new and unused ASI **ASIC/3 9520** Controllers in existing large Honeywell control box.
- Provide and install all sensors, control wiring, and associated electrical to power and operate devices to match operation in Quad A.
 - o Discharge air sensor
 - Return air humidity sensor
 - Chilled water actuator
 - Reheat water-actuator
 - Supply fan status indication
 - Outside air damper control
 - Float switch on emergency drain pan
- Provide and install ethernet communications from Quad B to Boiler Room Office to wirelessly integrate the new controls into the existing ASI workstation located in the Site mechanical room.
- Provide graphics, alarms, and trends on front end workstation for new controllers

Any and all items not specifically listed shall be included when deemed required as part the scope in order to complete the work. Contractors shall determine a comprehensive scope of work through review of the Drawings & Specifications and review of site conditions by attending the non-mandatory project site pre-quote conference walkthrough.
