Section 1.5 Proposal Response Format – Section C. <u>Respondent Qualifications and Experience</u>: - <u>REVISED</u>

History and background of Respondent with a report of staff numbers and job classification categories, strength and stability, related services provided to government entities, existing customer satisfaction, volume of merchants, etc.

Respondent should provide a description of Recent Projects completed by the Respondent as requested. The description of Recent Projects should include the following:

- 1. Complete list of representative stormwater management projects which enhanced detention capabilities in critical drainage areas which the Respondent or Team member has provided engineering services including the name and address of the Owner, Owner contact name, telephone number and email address, the type of project, and the total amount of funding (*past 10 years*).
- 2. Complete list of representative nonstructural mitigation/flood risk reduction and public services projects of similar nature that enhanced detention capabilities in critical drainage areas, protected facilities from flood damage, improved stormwater management, and provided increased greenspace, which Respondent has provided engineering and landscape architectural services, including the name and address of the Owner, Owner contact name, telephone number and email address, the type of project, and the total amount of funding (*past 10 years*).
- 3. Complete list of CDBG or other federally funded projects which the Respondent has provided engineering services, including the name and address of the Grantee, Grantee contact name telephone number, and email address, the type of project, the total amount of funding, and the year of award (*past 10 years*).
- 4. Complete list of Other Recent Projects for which the Respondent has provided engineering services (*past 3 years*) including the:
 - Name of the client;
 - Year of the assignment and length of time to complete the project;
 - Nature of the services rendered; and
 - Professionals assigned to the project who are also proposed to serve on this assignment.
